

NAME CHANGES

If a voter has changed their name, BUT HAS NOT MOVED, they do NOT need to update their registration with the Board of Elections and ARE allowed to vote on the machine.

They will sign their old name above their pre-printed signature, and then sign their new name in the signature box.
