2025 Ballot Propositions – Broome County

STATE

Amendment to Allow Olympic Sports Complex in Essex County on State Forest Preserve Land

Allows skiing and related trail facilities on state forest preserve land. The site is 1,039 acres. Requires State to add 2,500 acres of new forest land in Adirondack Park.

A “YES” vote authorizes new ski trails and related facilities in the Adirondack forest preserve.

A “NO” vote does not authorize this use.

TOWN – VESTAL

Shall the Town Board of the Town of Vestal by annual resolution be permitted to appoint a Receiver of Taxes for a term of one year and provide that if the Town Clerk or other Town official is the appointee, it shall be an individual and not an office appointment, and upon such terms as agreed between the Town and the appointee.

TOWN – UNION

Shall The Annual Contribution Of The Town Of Union For The Operating Budget Of The George F. Johnson Memorial Library Be Increased By Three Hundred Thirty-Six Thousand Seven Hundred Forty-Nine Dollars And Ten Cents (\$336,749.10) To The Sum Of One Million Four Hundred Fifty-Nine Thousand Two Hundred Forty-Six Dollars And Ten Cents (\$1,459,246.10) Annually, And Shall The Annual Contribution Of The Town Of Union For The Operating Budget Of The Your Home Public Library Be Increased By Twenty-Three Thousand Three Hundred Eighteen Dollars (\$23,318) To The Sum Of Eight Hundred Thousand Six Hundred Dollars (\$800,600) Annually?
